There are various requirements for initial and continued membership to the organization, which have been developed to insure harmony and effective operation of the department.

- 1. Formal application through an active member submitted to the Volunteer Chief, First or Second Assistant Chief, or any other fire officer of the association, on an Official Association Application Form.
- 2. Applicants membership in this association shall be at least 18 years of age, of good moral standing, sober, law abiding habits, possessing visible means of support and furnish a physician's statement showing the same to be free from physical infirmities.
- 3. A committee of five (5) members appointed by the Volunteer Chief will screen all applicants. The committee shall inquire into and report to the volunteer Chief on all eligible applicants for acceptance into the association.
- 4. After acceptance into the association, the Volunteer Chief and the committee, in the presence of his or her sponsor, will advise a new member on general association and fire department policies.
- 5. It shall be the responsibility of all applicants, once accepted to membership, to abide by all Association by-laws and policies.
- 6. All applicants shall be financially responsible for all association equipment issued to them.

The above are minimum requirements for membership to the Fire District Association. The degree of spirit and cooperation of its members determine the effectiveness of the Association.

Each and every member of this association is expected to perform duties of a firefighter faithfully and conscientiously and to use his or her utmost endeavors to promote the interest and welfare of the association at all times.
